**FURTHERMORE**

**USERS (excluding those enrolled part-time):**

- Students enrolled on the first year of any degree course who are eligible for a scholarship but who are not beneficiaries;
- students enrolled on the first year of Advanced/3-year/2-year (Sup./trienni/bienni) courses at Conservatoires, Schools for Linguistic Mediators and CIELS who are eligible for a scholarship but who are not beneficiaries

This concession is valid from the date of the application and for the entire period of use of the benefit (from 01.01.2021 to 31.12.2021).

**REQUISITES (to be possessed jointly):**

**Financial Requirements:** those necessary for the regional scholarship competition  
**OR Academic Merit:** 70% of that required for entry to the Regional Scholarship Competition (by 10.08.2020)

**USERS (excluding those enrolled part-time):**

- students enrolled on old and new system degree courses;
- students enrolled/pre-enrolled on the 1st year of degree courses who are not eligible for or do not require Regional Scholarship or who are awaiting evaluation or scholarship holders (first and subsequent years) from Regions-Autonomous Provinces-University who have renounced the Scholarship from the Veneto Region;
- students enrolling for specialisation course (Laurea Magistrale) with pre-enrolment on Uniweb (by request);
- students enrolled at Schools for Specialisation and for Research Doctorates at the University of Padua;
- students enrolled on Advanced/3-year/2-year (Sup./trienni/bienni) courses at Conservatoires, Schools for Linguistic Mediators and CIELS;

**THE QR Code AND PAPER VOUCHERS ARE STRICTLY PERSONAL AND NON-TRANSFERABLE AND MUST BE SHOWN WHEN TAKING MEALS.**

***Students must promptly notify the Right to Study Sector (by initiating a "Ticket" at the Sportello Studente/Student Help Desk) for the deactivation of any lost or stolen codes/vouchers to prevent improper use by third parties.***

**Tariff updates will be valid from 1 January 2021.**

**Students who are entitled to a free meal can take either lunch or dinner.**

**Students enrolled on the first year who are beneficiaries of scholarships in assignments subsequent to the first, can ask ESU for the reimbursement of lunches paid from 1 January 2021, by filling in the specific online form available on the website [www.esu.pd.it](http://www.esu.pd.it) > Servizi alla persona/Personal services> Elenco servizi online/List of online services.**
